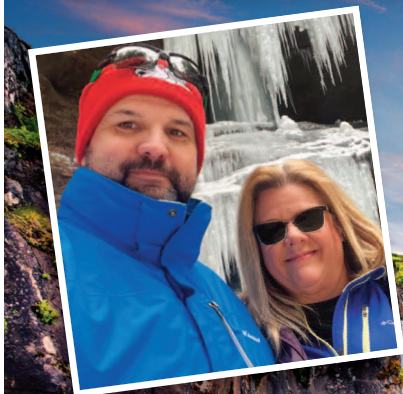

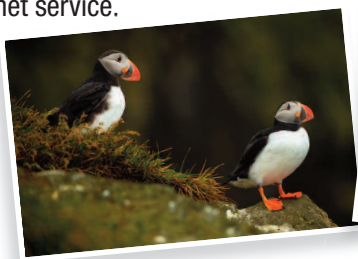

# ITINERARY HIGHLIGHTS

## Seydisfjordur Iceland

Seydisfjordur is an eclectic little town, tucked away at the end of a deep fjord in the east of Iceland. Surrounded by volcanoes, waterfalls, and in summer, green fields dotted with purple lupins, this former hub for herring fishing is a favorite stop on cruises. Walk alongside colorful wooden homes and the famous rainbow-painted street leading to the pretty blue church as you enjoy the fresh, crisp air. Immerse yourself in Icelandic art culture, and celebrate Seydisfjordur's rich history as a creative community. Venture through incredible natural surroundings as you trek to the cascading Gufufoss waterfalls,



mud bath at Lake Myvatn, or join a whale-watching cruise to spot humpback and minke whales and orcas. A day trip to Siglufjordur is a chance to visit the quirky but wonderfully informative Herring Era Museum, one of Iceland's best cultural attractions.

## Isafjordur, Iceland

Framed by a dramatically sweeping U-shaped valley, sleepy Isafjordur is the gateway to the starkly beautiful Westfjords. Visit the Dynjandi bridal veil waterfall, which is more than 300 feet tall. Kayak the glassy waters of the fjord, or spend time at a traditional turf farm to learn about rural life in the "Land of Ice and Fire". At the nearby fishing village of Sudavik, you can make your own chocolate at Saett & Salt, and learn about



and wander along the shore looking out for seals and porpoises before continuing on your Iceland cruise.

## Akureyri, Iceland

Located at the head of a deep fjord, Akureyri is the gateway to the wild natural beauty of northern Iceland. Visit Godafoss to marvel at the magnitude of the thundering, 40-foot-tall waterfall. Experience an authentic Icelandic



Iceland's only native land mammal at the Arctic Fox Center.



## Reykjavik, Iceland

Cool, compact Reykjavik is one of Europe's most exciting capitals. This cultural hub is filled with innovative museums, striking architecture, and fine dining. Admire the futuristic architecture of the Harpa Concert Hall and the Hallgrímskirkja church, and browse the shops for chunky Nordic knitwear and striking jewelry. The famous Blue Lagoon geothermal spa is easily accessible, while the dramatic scenery of the Golden Circle, including the plunging Gullfoss waterfall and the great Geysir, is a popular day trip.

This document provides a summary of important information regarding your cruise vacation. If you have any questions, please contact Magic Cruises & Tours (MAGIC).

**Payment Requirements:** Accommodations in each category at the discounted rates are limited and subject to availability. Reservations are made on a first-come, first-served basis, while supply lasts. **Deposit:** \$350 per person is required to secure your reservation.

**Final Payment:** The balance is due in full no later than **April 17, 2026**. Additional payments are accepted at anytime until final payment. Cruise payments can be made by check or credit card (VISA, MasterCard, or Discover preferred). Discounted group rates may not be combinable with other discounts or coupons.

**Travel Insurance:** Policies are available for purchase to protect you in case the unexpected occurs. Travel insurance provides coverage for events such as trip cancellation, interruption, damaged baggage, and medical expenses. [Celebrity Cruise Care](#) or [Allianz](#) policies are available. Cost is based on your cruise fare. Some restrictions and limitations do apply. Coverage must be purchased or declined in writing no later than final payment. Please contact MAGIC for details.

**Proof of Citizenship:** A US passport book valid for 6 months after the return date is required for this itinerary. It is the responsibility of all non-U.S. citizens to check with the local immigration office, embassy, or consulate to determine documentary requirements. There is no refund if a passenger is denied boarding the ship for lack of proper documents. [ETIAS](#) is a new European online travel authorization program scheduled for implementation in 2025 that might apply to this trip.

**Airfare:** Flights will be available through the Flights by Celebrity program, they may be booked independently directly through your airline of choice, or MAGIC may offer group flights. Airfare payments and cancellation fees are subject to separate terms and conditions (many flights are non-refundable). Flights will be available starting Fall of 2025.

**Travel Arrangements/Transfers:** Flights should be scheduled to arrive no later than 1PM into Reykjavik (KEF) August 1, 2026. Return flights may be scheduled to depart no earlier than 11:00 AM from Reykjavik (KEF) August 8. Airport Transfers may be purchased for transportation between Reykjavik (KEF) airport and the pier on August 1st and/or the return on August 8th. These can be added in your Cruise Planner or added to your cruise reservation through MAGIC.

**Pre & Post-Cruise Packages:** Interested in spending some extra time in Reykjavik? It is highly recommended for guests to arrive by July 31, the day before embarkation, to allow for travel delays. Hotel reservations open approximately 10-12 months in advance.

**Travel Documents:** Online Check-in for all guests must be completed in order to view and print your Xpress Pass boarding passes. The check-in opens 45 days prior to your cruise. It can be accessed online at [www.celebritycruises.com/account](http://www.celebritycruises.com/account) or in the [Celebrity Cruises App](#).

**Optional Excursions:** Celebrity Cruises offers a wide variety of optional tours to enhance your experience. Typically, these tours can be reviewed and purchased online in your "Cruise Planner" or in the Celebrity Cruises App approximately 6-9 months prior to travel.

**Not Included:** Items not part of the cruise vacation price include (but are not limited to): airfare, travel insurance, hotel, optional tours, gambling, laundry and items of a personal nature. Celebrity Cruises reserves the right to reinstate a fuel surcharge.

**Smoking Policy:** Celebrity Cruises prohibits smoking in staterooms and balconies. Designated smoking areas are available. \$250 fine for violations.

**Guests with Special Needs:** Celebrity requires notification of any special medical, dietary, physical (including pregnancy) or other requirements of passengers at the time of booking. Please inform MAGIC of any special needs/requirements when making your reservations.

### IMPORTANT! PLEASE VERIFY:

Names listed under Passenger Details on your invoice must match the names on your passport/proof of citizenship. Call us right away with any corrections. Name changes/corrections will be subject to fees/penalties from the Suppliers and may not be permitted.

### PASSPORT INFORMATION:

U.S. Citizens leaving the country are required to carry a Passport Book valid for 6 months past your return travel date. Some cruises sailing roundtrip from a US port may allow guests to travel with a government issued birth certificate and state issued ID (like a driver's license) and a marriage license for married ladies (proving name change), in lieu of Passport Book. Passport requirements may change at any time and without a Passport Book you will not be able to fly to/from outside the USA in case of an emergency. Passport Cards are not applicable for international air travel and not recommended. Flights within the U.S. require a REAL ID Driver's License or Passport Book. If you are traveling with minors/children, a passport book, parental permission form and original birth certificate may be required. MAGIC strongly recommends that all Passengers travel with a valid Passport Book. If you are not a US Citizen, it is your responsibility to check with your consulate for travel requirements.

Certain destinations may also have their own requirements/restrictions for entry. Travel Visas can be issued online for some countries, but other countries require forms and passports to be mailed to the consulate. There is an extra fee for Travel Visas. Some countries will deny entry if you have been convicted of a felony, have a drunk driving offense or owe back child support (examples only). It is each passenger's responsibility to confirm these requirements. Go to [www.travel.state.gov](http://www.travel.state.gov) for more details. Other sources of information may be CIBT Visa/Passport services or the web site of the individual country. It is the passenger's responsibility to confirm any requirements for flights, entry into a certain country or to board a cruise ship. If entry/boarding is denied no refund will be issued and MAGIC cannot be held responsible.

### TRAVEL INSURANCE:
